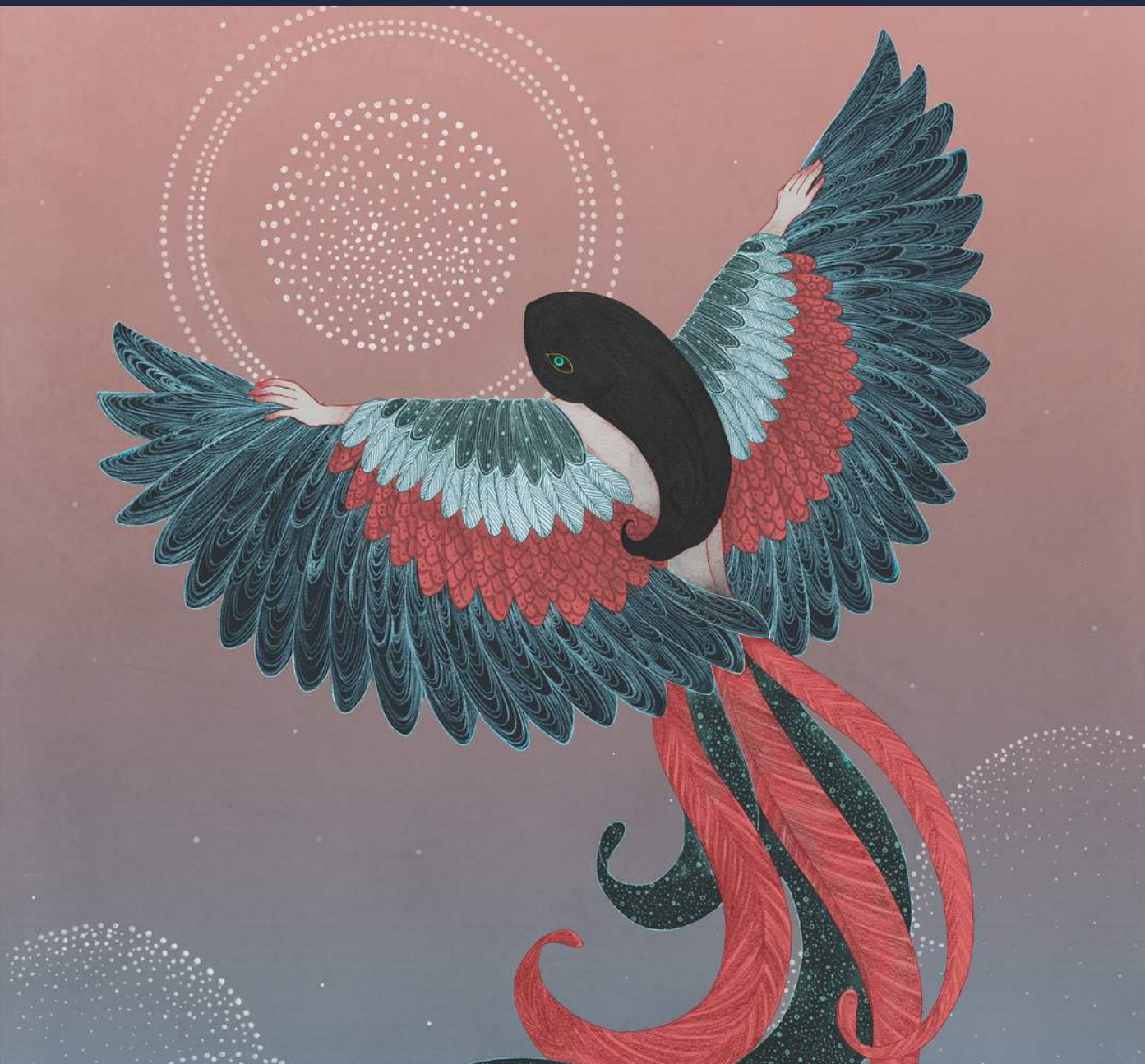

Catalyst Award

Women of color are leading the environmental movement, advocating for clean air and water, building a green economy, fighting polluters, expanding access to healthy food, and much more.

Despite this critical work, they do not receive adequate funding, support, or recognition for their leadership. Less than 1 percent of foundation giving goes to women and girls of color, and according to Green 2.0, organizations led by people of color receive less than one percent of multiyear operational budget grants.

Rachel's Network is working to address this disparity. We launched the Catalyst Award in 2019 to shine a light on women of color carrying Rachel Carson's legacy.

Each year, the award provides women environmental leaders of color with a personal prize (\$10,000); a well-being stipend (\$5,000); and an organizational grant (\$10,000, if applicable). The program has granted more than \$1.7 million to 120 women leaders of color and their organizations. Awardees are selected by a committee of former awardees.

Catalyst Retreat



The word “care” comes up a lot at Rachel’s Network. Care was also a big impetus behind our inaugural wellness and restoration retreat. In November, Rachel’s Network hosted the first of its kind retreat for women of color leaders at the Kripalu Center for Yoga & Health in Stockbridge, Massachusetts.

Awardees, finalists, and staff were also joined by grantees of the Tides Foundation’s Women’s Environmental Leadership (WE LEAD) fund for a gathering focused on care and restoration for women environmental leaders of color.

With news of the election results still fresh, the retreat served as a vital gathering space for 14 leaders to process their emotions and fears in a supportive space. The agenda included shared meals, a guided hike, yoga classes, and reflective time in nature.

Gatherings like these will be vital over the next four years as women leaders face increased threats to their wellbeing and communities. We hope to continue creating spaces for environmental leaders to come together, rest, and connect to each other.

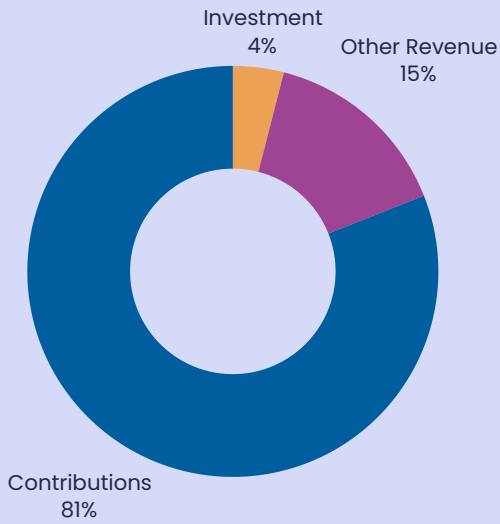

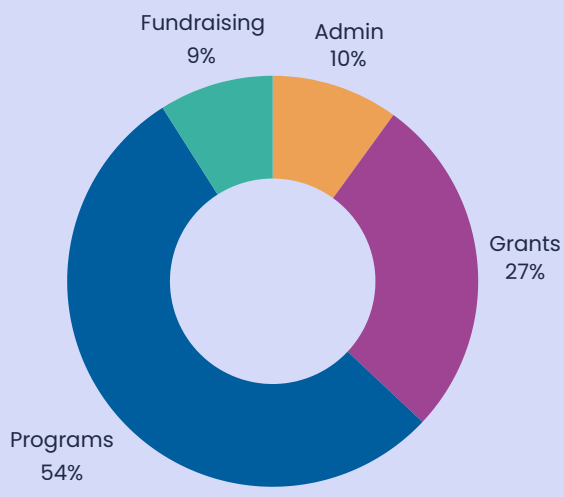
